Dear Eighth Grade Parents,

On Thursday, May 1, 2025, the 8th grade class of Penn Middle School will be taking a field trip to Gettysburg, Pennsylvania. As most of you know, Gettysburg was the scene of the battle that many historians consider to be the turning point of the Civil War. The trip will be of educational, cultural, and social value for our students. Our plans include a 5 tour of the battlefield, a visit to The National Cemetery as well as a tour of *The Shriver House*, a "period-style" home of the Civil War era.

As we approach the date of the trip, there are a number of items that you should be aware of to prepare your son or daughter for this enjoyable day.

**Itinerary—Departure** from Penn Middle School at 5:00 am, via coach buses. (Students should plan to arrive 30 minutes prior to departure at 4:30 am). Students will return to Penn Middle School at approximately 8:30 pm.

**Cost:** \$30.00 per student. Payable with a returned permission slip. Cash or Check payable to **Penn Middle School**.

**Meals:** A Pizza Lunch from Tommy's Pizza of Gettysburg (<a href="https://www.tommyspizzainc.com/">https://www.tommyspizzainc.com/</a>) is included for students and chaperones. A dinner stop is planned on the Pennsylvania Turnpike; students and chaperones should budget \$15 for this stop. If your student has any food allergies, please review the menus.

**Money:** Students may bring money for the purchase of snacks and souvenirs. We suggest students do not bring large amounts of money -- nothing over \$25

Cameras: Will be permitted.

**Cell phones:** Will be permitted on the bus only, they should be turned off when visiting sites.

Penn Middle School is not responsible for any lost, stolen, or damaged personal items.

**Partners:** The students may choose a partner for the day. That person must be listed on the attached permission slip. No male/female partners. If students need a partner, one will be assigned to you.

**Chaperones:** We are in need of 10 to 15 adult chaperones to accompany us on the trip. If you are interested, please fill in the necessary information on the permission slip. There will be no charge for chaperones. This year chaperones may choose to purchase the Gettysburg T- shirt for \$20.


**Students NOT going on the trip:** Students not participating will come to Penn Middle School for a regular day and do assigned work, then watch the movie "Gettysburg".


